Dear Friends:

As my first year on Council comes to a close, I want to first thank you for all your support and encouragement. We've had much to celebrate—and some serious challenges to face. To be sure, there are other hurdles ahead. I am certain however, that we can overcome even the toughest circumstances if we work together.

In my role as your Councilman, I was fortunate to receive support for a number of efforts to improve our city. I introduced a resolution to explore the relocation of the city's school bus fleet, but I am hopeful that the buses will be relocated sometime next year. Responding to the voices of so many residents, my colleagues and I co-sponsored a resolution to begin the charter revision process. The Charter Revision Commission was empanelled in Sep-

tember, and public hearings have begun and will continue in the coming months. Moreover, in the hopes of keeping the Women's Big East Tournament in the city, I submitted a resolution to alleviate some of the costs associated with the events. In addition, a number of amendments to our municipal code have been adopted or proposed, including the formation of a Freedom Information Advisory Board and the continuation of the Historic Preservation Commission ordinance.

On a personal note, I have been just as blessed. In June I became engaged to Marilyn. In addition, we added Dublin, our goldendoodle, in December. My sister Jessica also got engaged to her fiancé, Joe.

FOR OUR FINEST, BRAVEST

Hartford's Police Officers and Firefighters put their lives on the line daily to protect and serve our residents. In the tragic instance that they make the ultimate sacrifice, Matt wanted to ensure that their families would receive some measure of support. So in November, he proposed an ordinance that would provide a tax abatement to surviving spouses of police and fire personnel who die in the line of duty. Authorized by state statute, the measure would allow a tax credit of \$500 on personal property. "This is one small way we can honor the dedication and commitment of our public safety officers," Matt said. Both Police Chief Daryl K. Roberts and Fire Chief Charles Teale support the measure, as does Police Union President Richard Rodriguez. The full Council will consider the ordinance in January. Matt is also exploring the possibility of including Public Works and Health and Human Services personnel in the proposed benefit.

CROSS-TOWN CONVERSATION

For months, Hartford resident Anton Rick-Ossen has been working to garner support for a cross-town bus route, which would travel between the North and Southwest areas of the city. The route would eliminate the need for residents from most neighborhoods to take more than one bus; currently, most citizens have to take a bus downtown and transfer to reach their destination in another city neighborhood.

Rick-Ossen sought Matt's support for the measure, and in response, he reached out to the Hartford delegation—Sens. Eric Coleman and John Fonfara; Reps. Marie Lopez Kirkley-Bey, Ken Green, Doug McCrory, Minnie Gonzalez and Kelvin Roldan; and Rep.-Elect Hector Robles. In his letter, Matt asked the state officials to consider adopting measures that would support the establishment of the bus route. "While creating bus routes is not managed at the municipal level, I support Anton's efforts," Matt said. "I'm hopeful that our state leaders can take the necessary steps to make this happen."
