



40-1 EDUCATION

Mission Statement:

Hartford's System of Schools exists to provide all of its students with access to participation in the global economy, through attainment of the Academic Standards of the State of Connecticut, as well as readiness for post-secondary education.

Significant Features:

The 2009-2010 Recommended Budget is \$287,554,001. This reflects an increase of \$3,000,000 or 1.1% from the 2008-2009 Adopted Budget. The Board of Education is projecting to eliminate an additional 225 positions for fiscal year 2009-10. Continuing as part of the Recommended Budget, the fringe benefits costs are incorporated as part of the direct appropriation budget.

The Hartford Public School System receives funding from other sources that include federal grants, state grants, foundations, private sources, as well as other donations and contributions. This funding is categorized as the Special Funds Budget. The 2009-2010 Special Funds Budget projected amount totals \$84,040,255. This figure does not include any federal stimulus funds that Hartford's System of Schools may receive throughout the school year.

The Indirect Municipal Contribution for the Board of Education is \$18,812,869. This cost is attributed to principal and interest payments in the amount of \$13,592,869 for bond maturities and other obligations for the construction and renovation of various schools. The balance of \$5,220,000 is related to the projected *In-Kind Services (ED-001) the Municipality provides the Hartford Public School System throughout the fiscal year.

Therefore, the combined budget for the Hartford Public School System would total \$390,407,125.
